Enquadramento

No período de 1 de julho de 2020 a 31 de dezembro de 2021, a Alemanha, Portugal e a Eslovénia formarão o Trio de Presidências do Conselho da União Europeia. Em 2007-2008, os três Estados-Membros da UE formaram o primeiro Trio de Presidências da história da UE. Cada Trio de Presidências elabora um projeto de programa conjunto para o período do Trio, em cooperação com o Presidente do Conselho Europeu, a Comissão e - na área das relações externas da UE - com o Alto Representante para os Negócios Estrangeiros e a Política de Segurança (“Programa de 18 meses do Conselho” ou “Programa do Trio”).

Measures against Covid-19 are needed, but their impact on privacy and freedom must be proportionate and temporary, said Maria Arena, the chair of the human rights subcommittee.

The [Covid-19 crisis](#) has put some of the fundamental principles of the EU to the test. During a Facebook Live, [Maria Arena](#), chair of Parliament's human rights subcommittee, talked about the human rights aspects of the EU response to the pandemic.

“The EU has played an important role in enabling the free movement of goods and services, including medicines and equipment, to countries that needed them the most, Arena said, but it is “very important to come back to freedom of movement for citizens”. Europe is not Europe without that, she said.”

During the coronavirus pandemic economic activity slowed, causing a reduction in carbon emissions but leaving the EU facing recession. In a resolution adopted on 15 May 2020, Parliament called for an [ambitious recovery plan with the Green Deal at its core](#).

In response, the European Commission came up with Next Generation EU, a €750 billion [recovery plan](#). The plan, along with the next [EU long-term budget](#) which still needs to be approved by member states and Parliament, aims to build a greener, more inclusive, digital and sustainable Europe and increase resilience to future crises such as the [climate crisis](#).

Artificial intelligence (AI) is probably the defining technology of the last decade, and perhaps also the next.

The European Commission recently closed the consultation period on its [white paper on AI](#) and the European Parliament has voted in favour of launching a [special committee on AI in the digital age](#). In this context, STOA has published a timely study on AI, which provides accessible information about the full range of current and speculative AI techniques and their associated impacts, and sets out several regulatory, technological and societal measures that could be mobilised in response.

While many countries, notably in Europe, are currently easing restrictive measures aimed at containing the spread of the coronavirus (Covid-19), the latter is now rapidly spreading in other parts of the world, notably in the Americas and Indian sub-continent. The number of people globally who have tested positive for the disease is now approaching 10 million, exacerbating an already precarious situation in certain conflict-afflicted areas, such as Yemen. In Europe, analysts continue to examine the various ways of financing and promoting economic recovery from the depressive effects of the pandemic.

COVID-19 has brought unprecedented challenges to the global community. Apart from the large number of human losses and the intense pressure on the healthcare systems, the coronavirus has been a “crash test” for the world’s economy.

Worldwide, businesses have been directly or indirectly affected in various sectors (horeca, retail, tourism, events, construction, production etc.). About 90% of small and medium enterprises (SMEs) in Europe [report loss of turnover](#). In the most affected sectors, 50% of companies are faced with liquidity problems, which may turn soon into the risk of insolvency. Furthermore, according to the latest SMEUnited survey, the restart seems to be slower than hoped and the crisis will last into 2021.

O Instituto Nacional de Estatística disponibilizou a terceira edição da publicação nacional de acompanhamento estatístico da Agenda 2030 da ONU, intitulada “Objetivos de Desenvolvimento Sustentável: Indicadores para Portugal | Agenda 2030”.

A partir da monitorização dos indicadores disponíveis é possível ter uma noção sobre o desempenho do país em relação aos ODS, verificando-se progressos em alguns deles, nomeadamente nos domínios da redução da pobreza, do acesso à saúde e das energias renováveis.

[Refira-se] que a informação deste destaque não reflete ainda a situação atual determinada pela pandemia Covid19. É de esperar que as tendências aqui analisadas se alterem substancialmente.
