European Parliamentary Research Service Blog | EU Budget And Recovery Fund: Is It A Done Deal? [What Think Tanks Are Thinking]

After nearly five days of tough negotiations, the European Council agreed on the EU's next seven-year budget, the [Multiannual Financial Framework \(MFF\)](#), worth more than one trillion euros from 2021 to 2027, and crucially, on an additional 750-billion euro fund to help countries recover from the economic downturn caused by the coronavirus pandemic.

Strong together: Maas and Borrell take stock after the meeting of EU foreign ministers in Berlin

At Gymnich, the informal meeting of EU foreign ministers, the focus was on relations with Turkey and Russia, as well as on the situation in Belarus and the EU's strategic response to COVID-19.

There has been no let-up - in recent weeks, which have proven so eventful, there have been extremely dynamic developments in a host of topics. It is not just that all states are still dealing with the COVID-19 pandemic and the impact of that crisis. The situation in Libya, the eastern Mediterranean and in Belarus and Lebanon is also tense. There are many fronts in foreign policy where the European Union is called upon to take a stance and take action. The so-called [Gymnich meetings](#), hosted every six months by EU High Representative Josep Borrell and the foreign minister of the member state holding the Presidency, on this occasion Foreign Minister Heiko Maas, provide an opportunity to talk about current crises and at the same time discuss more fundamental foreign and security policy issues of strategic importance in an informal setting.

IEA | Sustainable Recovery | World Energy Outlook Special Report

Since the scale of the economic crisis began to emerge, the IEA has been leading the calls for governments to make the recovery as sustainable and resilient as possible. This means immediately addressing the core issues of global recession and soaring unemployment – and doing so in a way that also takes into account the key challenge of building cleaner and more secure energy systems.

[in Executive summary] The biggest global economic shock in peacetime since the 1930s is having a severe impact on employment and investment across all sectors, including energy. With the global economy set to shrink by 6% in 2020, some 300 million jobs may have been lost during the second quarter of the year. This disruption has sent shock waves through energy markets, with global energy investment expected to shrink by an unparalleled 20% in 2020.

The energy sector, particularly electricity, has played a critical role in the global response to the Covid-19 crisis. Uninterrupted energy supplies have enabled hospitals to provide care, food and other essentials to be delivered, and millions of people to work and study from home while maintaining social contact online. Without access to reliable and affordable electricity, the lockdowns introduced by governments to tackle the public health crisis would have resulted in far greater economic damage.

OECD | Rising uncertainties from Covid-19 cloud medium-term agricultural prospects

The joint *OECD-FAO Agricultural Outlook 2020-2029* report finds that over the next ten years supply growth is going to outpace demand growth, causing real prices of most commodities to remain at or below their current levels. Fluctuations in the driving factors of supply and demand could lead to strong price variations around this general path. At the same time, a decrease in disposable incomes in low-income countries and households caused by Covid-19 is expected to depress demand in the early years of this outlook and could further undermine food security.

A partir da monitorização dos indicadores disponíveis é possível ter uma noção sobre o desempenho do país em relação aos ODS, verificando-se progressos em alguns deles, nomeadamente nos domínios da redução da pobreza, do acesso à saúde e das energias renováveis.

[Refira-se] que a informação deste destaque não reflete ainda a situação atual determinada pela pandemia Covid19. É de esperar que as tendências aqui analisadas se alterem substancialmente. De qualquer modo, a informação disponibilizada será útil para estabelecer uma referência para avaliar desenvolvimentos futuros.
