### Cimeira social será o evento central da presidência portuguesa da União Europeia

O Primeiro-Ministro António Costa, na conferência «Presidência do Conselho da União Europeia 2021», na Universidade Católica (Lisboa, 23 de Novembro de 2020), salientou que a cimeira social e o Conselho Europeu informal, nos dias 7 e 8 de maio, no Porto, com a aprovação final de uma declaração vinculativa sobre o pilar social da União Europeia, será «o evento central» da presidência portuguesa.

### G20: Global co-operation and strong policy action needed for a sustainable recovery - OECD

The COVID-19 crisis has exposed major weaknesses in our economies that can only be fixed through greater global co-operation and strong, targeted policy action, according to a new OECD report presented to the Leaders of the G20 countries at their virtual Summit this weekend.

**New Horizons**, a report requested by the G20 to support its Action Plan in response to the crisis, says governments need to plan now for the recovery while continuing to live with the virus. Emergency economic measures to tackle the crisis will need to be adapted, support to people and businesses become more targeted, and new policies put in place to make the objective of a stronger, sustainable and inclusive global economy, a reality.

### ECFR | The best defence: Why the EU should forge security compacts with its eastern neighbours

- The European Union and its member states have yet to start upgrading EU policies to their declared ambitions of a more geopolitical and strategically sovereign EU.
- The EU spends more on support for Eastern Partnership countries than the United States does, but Washington has long taken care of security sector reform and capacity building there.
- If the EU is to be more geopolitically influential in its own neighbourhood, it needs to start developing strategic security partnerships with key neighbours to the east and the south.
- The bloc should do so by creating a security compact for the Eastern Partnership, comprising targeted support for intelligence services, cyber security institutions, and armed forces.
- In exchange, Eastern Partnership countries should conduct anticorruption and rule of law reforms in the security sector.
- The EU should treat this compact as a pilot project that it will implement with important partners in the Middle East and Africa.

## ECDPM | Africa-Europe relations beyond 2020: Looking through a gender lens

The year 2020 is a pivotal year for stepping up action on gender equality. It marks the 25th anniversary of the Beijing Fourth World Conference on Women and the global community is celebrating the 20th anniversary of the adoption of UN Security Council Resolution 1325 on women, peace and security.

A comprehensive partnership between Africa and Europe will be less effective if gender considerations are not an integral part of joint cooperation. Inclusion of the gender dimension is particularly key in COVID-19 recovery efforts in the short, medium and long term. This paper provides food for thought and points of entry to facilitate gender equality and women's empowerment in thematic areas of importance for the partnership.

## Ellen MacArthur Foundation | The 2020 Progress Report

This report is the second in a series of annual New Plastics Economy Global Commitment progress reports. It looks at how Global Commitment signatories, which together account for more than 20% of the plastic packaging market, are faring against their 2025 targets on plastics. After a quantitative baseline was set by [the first report in 2019](#), this 2020 report provides the first insight into the trajectory of progress against that baseline.

Examples and case studies of all these changes are taken from power systems around the world. Existing frameworks that value and provide electricity security are described, and best practices offered along with recommendations to guide policy makers as they adjust to the various trends underway.

## European Statistics (Eurostat)

### Circular Economy - Overview

A circular economy aims to maintain the value of products, materials and resources for as long as possible by returning them into the product cycle at the end of their use, while minimising the generation of waste. The fewer products we discard, the less materials we extract, the better for our environment.

### Climate Change - Overview

Climate change refers to a **change in climate patterns** due to human activities, going beyond the natural variability in the climate. This is caused by **greenhouse gases** emitted into our atmosphere. Among the **drivers** of these emissions are the burning of fossil fuels, industrial processes, livestock farming, and waste treatment.

### Objetivos de Desenvolvimento Sustentável

3ª edição da publicação sobre Indicadores dos Objetivos de Desenvolvimento Sustentável (ODS) em Portugal - 2010 – 2019 (divulgado a 22 de Maio de 2020)

O Instituto Nacional de Estatística disponibilizou a terceira edição da publicação nacional de acompanhamento estatístico da Agenda 2030 da ONU, intitulada “Objetivos de Desenvolvimento Sustentável: Indicadores para Portugal | Agenda 2030”.

A partir da monitorização dos indicadores disponíveis é possível ter uma noção sobre o desempenho do país em relação aos ODS, verificando-se progressos em alguns deles, nomeadamente nos domínios da redução da pobreza, do acesso à saúde e das energias renováveis.

[Refira-se] que a informação deste destaque não reflete ainda a situação atual determinada pela pandemia Covid19. É de esperar que as tendências aqui analisadas se alterem substancialmente. De qualquer modo, a informação disponibilizada será útil para estabelecer uma referência para avaliar desenvolvimentos futuros.

### Contas do Setor de Bens e Serviços Ambientais (divulgado a 14 de Fevereiro de 2020)

O VAB do setor dos bens e serviços ambientais diminuiu 0,9% em 2017, mas as exportações e o emprego cresceram mais do que no total da economia – 2017

### Paridades de Poder de Compra

O Produto Interno Bruto per capita, expresso em Paridades de Poder de Compra, situou-se em 76,8% da média da União Europeia em 2018 (76,6% em 2017). A Despesa de Consumo individual per capita aumentou de 81,5% da média da União Europeia em 2017 para 82,9% em 2018

A publicação Estatísticas do Ambiente, na sua edição de 2019, segue a linha editorial e a estrutura do ano anterior e apresenta uma análise detalhada do setor do ambiente privilegiando-se a divulgação da informação através de quadros de indicadores síntese, figuras e mapas

A Conta de Fluxos de Materiais pretende retratar, no âmbito do ambiente natural, a relação da economia nacional com o resto do mundo, constituindo uma fonte de informação importante na monitorização da economia circular
